

**NOTICE BY TRUSTEE OF ABANDONMENT
OF FUNDS ON DEPOSIT IN ESTATE'S BANK ACCOUNT**

NO HEARING WILL BE CONDUCTED ON THIS MOTION UNLESS A WRITTEN RESPONSE IS FILED WITH THE CLERK OF THE UNITED STATES BANKRUPTCY COURT AND SERVED UPON THE PARTY FILING THIS PLEADING WITHIN FIFTEEN (15) DAYS FROM THE DATE OF SERVICE UNLESS THE COURT SHORTENS OR EXTENDS THE TIME FOR FILING SUCH RESPONSE. IF NO RESPONSE IS TIMELY SERVED AND FILED, THIS PLEADING SHALL BE DEEMED TO BE UNOPPOSED, AND THE COURT MAY ENTER AN ORDER GRANTING THE RELIEF SOUGHT. IF A RESPONSE IS FILED AND SERVED IN A TIMELY MANNER, THE COURT WILL THEREAFTER SET A HEARING. THE COURT RESERVES THE RIGHT TO SET ANY MATTER FOR HEARING.

1. The above debtors filed for relief under a Chapter 13 bankruptcy proceeding on June 12, 2000 and H. Michael Gross was appointed Chapter 13 Trustee. On July 24, 2000, the debtors filed a notice of voluntary conversion to a Chapter 7 proceeding, and the undersigned, STEPHEN J. ZAYLER, was thereafter appointed Chapter 7 Trustee.

2. While the debtors were in their Chapter 13 proceeding, they paid the sum of \$340.00 to the Chapter 13 Trustee representing their plan payments.

3. After the 341a hearing held in the Chapter 7 proceeding, the Trustee determined that this was a possible asset case because the debtor was a party in a personal injury cause of action. Thereafter, the Chapter 13 Trustee turned over the \$340.00 he had on deposit to the Chapter 7



Trustee who deposited such amount into an interest bearing bank account for the estate of the debtors.

4. The Chapter 7 Trustee has since learned that there is no value for the estate in the debtors personal injury cause of action, leaving the funds on deposit in the bankruptcy estate's bank account of \$340.00 plus accrued interest as the only asset to administer in the Chapter 7 proceeding.

5. The Chapter 7 Trustee believes that it would be burdensome for the bankruptcy estate to administer the \$340.00 plus accrued interest. Therefore, the Chapter 7 Trustee hereby ABANDONS the funds on deposit in the bank account for the above bankruptcy estate back to the debtors, ALAN C. AND RHONDA G. KELLEY, and will make such distribution to the debtors upon the expiration of the notice period stated above, if no response is filed.




