TRUSTEE'S MOTION TO PAY ADMINISTRATIVE CLAIMS

NO HEARING WILL BE CONDUCTED ON THIS MOTION UNLESS A WRITTEN RESPONSE IS FILED WITH THE CLERK OF THE UNITED STATES BANKRUPTCY COURT AND SERVED UPON THE PARTY FILING THIS PLEADING WITHIN TWENTY (20) DAYS FROM DATE OF SERVICE UNLESS THE COURT SHORTENS OR EXTENDS THE TIME FOR FILING SUCH REQUESTS FOR HEARING. THE COURT WILL THEREAFTER SET A HEARING. IF NO RESPONSE IS TIMELY SERVED AND FILED, THIS PLEADING SHALL BE DEEMED TO BE UNOPPOSED, AND THE COURT MAY ENTER AN ORDER GRANTING THE RELIEF SOUGHT. THE COURT RESERVES THE RIGHT TO SET A HEARING ON ANY MATTER.

TO THE HONORABLE UNITED STATES BANKRUPTCY COURT:

COMES NOW DANIEL J. GOLDBERG, the duly appointed and acting Trustee in the above entitled and numbered proceeding, and files this Motion to Pay Administrative Claims and would respectfully show the Court as follows:

A substantial part of the assets of this debtor consisted of live plants. Following the filing of the Chapter 7 proceeding by the debtor, it was necessary that the plants be fed and watered until such time as they could be sold. The debtor filed its Chapter 7 proceeding on Friday, September 29, 2000.

After an expedited hearing, this Court approved an auction sale for the plants and equipment to take place. The sale was held on Saturday, October 14, 2000. Workers were required to maintain the plants prior to the sale in order to maximize the sale results. The following is a list of said

af

workers, their pay rates prior to the Chapter 7 filing, the number of hours they worked and the requested compensation for said work subsequent to the Chapter 7 filing. Each was hired as an independent contractor, not an employee of the estate since the estate was to be liquidated immediately and not run as an ongoing business. The trustee believes that they performed necessary services for the estate and should be compensated accordingly and requests that the Court approve payment to these individuals as set out herein. Attached hereto as Exhibit "A" is the pay rate, number of hours worked and amount due for post petition work by each individual. The trustee believes that if these individuals are not paid, they will suffer individual hardships and that payment out of the ordinary course of administration is just and proper.

1. Tuan Vo worked from October 2, 2000 to October 11, 2000 taking care of the inventory of Harris Greenhouses until the Auctioneers assumed the care of same on October 12, 2000. is owed \$454.03 in compensation for his time.

2. Juan Aleman worked from October 2, 2000 to October 11, 2000 taking care of the inventory of Harris Greenhouses until the Auctioneers assumed the care of same on October 12, 2000. Mr. Aleman is owed \$539.75 in compensation for his time.


3. Tuan Dao worked from September 30, 2000 to October 11, 2000 taking care of the inventory of Harris Greenhouses until the Auctioneers assumed the care of same on October 12, 2000. Mr Dao is owed \$777.65 in compensation for his time.

4. Pedro Corona worked from October 2, 2000 to October 11, 2000 taking care of the inventory of Harris Greenhouses until the Auctioneers assumed the care of same on October 12, 2000. Mr. Corona is owed \$392.68 in compensation for his time.

5. Kieu Nguyen worked from September 30, 2000 to October 1, 2000 taking care of the inventory at Harris Greenhouses. Mr. Nguyen is owed \$64.90.

WHEREFORE, the Trustee prays that the above compensation fees be approved and the trustee permitted to pay such sums as are indicated herein.



**ORDER SUSTAINING TRUSTEE'S OBJECTION TO PROOF OF CLAIM #35  
FILED BY JEFFERSON COUNTY C/O CLAYTON E. MAYFIELD**

ON THIS DATE the Court considered the Trustee's objection to proof of claim #35 filed by Jefferson County c/o Clayton E. Mayfield (the "Claimant") on or about March 6, 2001 in the amount of \$2,034.04. The Trustee filed such objection on or about the 5th day of February, 2003. The Court finds that the objection to the claim contains proof sufficient to overcome the presumption of validity imposed by Fed. R. Bankr. P.3001(f) and was properly served pursuant to the Federal and Local Rules of Bankruptcy Procedure. The Court further finds that the objection contained the appropriate twenty (20)-day negative notice language, pursuant to Local Rule of Bankruptcy Procedure 9007, which directed the Claimant to file a written response within twenty days or the objection to claim would be deemed by the Court to be unopposed. Due to the failure of the Claimant to file a timely written response to the objection, the Court finds that good cause exists for the entry of the following order.

IT IS THEREFORE ORDERED that the Trustee's Objection to Proof of Claim filed by Claimant is SUSTAINED and that Claim #35 filed by Jefferson County c/o Clayton E. Mayfield is hereby disallowed as a secured claim and stricken from the claims docket.


