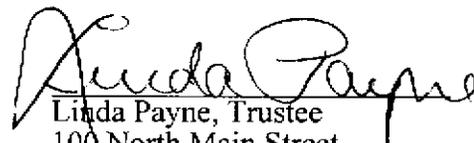
The Trustee of the estate presents the following final report:

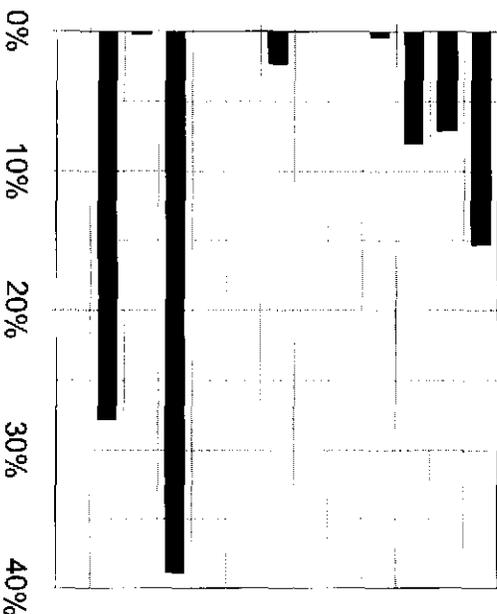
