Case background: This case ("SANJ"), along with 44 other related entities, were the company-owned Bennigan's and Steak and Ale restaurants, along with a few other specialized/corporate entities with their own tax ID numbers (and thus were separate case filings). Most of the case filings were similar to Steak and Ale of New Jersey - they were filed by the corporate ID for each state. The cases were jointly administered under the lead case #08-41898, S&A Restaurant Corp ("SACorp"). During case administration, it was discovered that liquor license rules varied by state. In New Jersey, the licenses could have significant value because there are a finite number of available license in Borough or Township, and they are "pocket licenses" and transferrable. Due the possible distribution to unsecured creditors in the New Jersey case, this case was not substantively consolidated with the other 44 which were under SACorp. See Orders dated 08/04/10 (to substantively consolidate and separately administer SANJ), and also Order dated 01/03/11 (which specified reallocation/reimbursement actual amounts and 7.25% of professionals' fees and expenses).

The Assets to SANJ: To summarize, the bulk of assets in the case were from sales of liquor licenses (asset lines 8 and 9). These were either transferred from SACorp (funds collected prior to the substantive consolidate order which allowed SANJ as a separately administered case), or were directly deposited to the SANJ bank account. Other assets are the remnant sales (asset 10) and miscellaneous deposits (asset 7), plus bank interest.

The Payments from SANJ: To summarize, the main categories of checks written/automatic deductions from the estate bank account were for professionals' interim and final fee applications, liquor license renewals, annual estate bond and bank service fees, and reallocation/reimbursement to SACorp.

Case administration summary: the SANJ and SACorp were administered jointly and final reports submitted at the same time. SANJ liquor license sales dictated the pace of case administration, and that was determined by the market for liquor licenses. The special counsel for Trustee, Jack Vasallo, provided valuable assistance to the estate in the marketing, renewals, sales, and successful transfer of liquor licenses. Of note, the last 3 licenses sold (Springfield, New Brunswick, and Upper Saddle River) had little to weak interest for a long period before realizing over \$300,000 to the estate in 2013. Claims reviewed and objections granted in late 2013/early 2014.
