
TRUSTEE'S FINAL REPORT, APPLICATION FOR COMPENSATION AND



**SCHEDULE B - APPLICATION FOR COMPENSATION**

COMPUTATION OF COMPENSATION

In calculating the trustee's maximum compensation for those cases in which a surplus is returned to the debtor, the amount of the surplus must be excluded from the base figure to which the allowable percentage rate is applied. Refer to 11 U.S.C. §326(a) which specifically excludes monies turned over to the debtor from being used as an element in the calculation of the maximum amount of compensation to which a trustee is entitled. The following formula was used in this case, which was filed 10/22/94 or later and in which the costs of administration were over \$44,250 but not more than \$946,750:

$$X = \frac{5750 + .05(265,306 - 50,000)}{.95}$$

$$X = \$17,384.53$$
