
1. This case was filed as a voluntary Chapter 13 on June 7, 1999 and converted to a Chapter 7 on February 28, 2000.





5. The trustee now believes this to be a No Asset case and is seeking permission from this court to return the \$815.00 plus any interest it earns to the debtor.




