4. Without the express permission of the Court, I may file electronically ONLY the following types of documents:
  - a. Proof of Claim, with related exhibits (event name: File Claim)
  - b. Creditor's Notice of Transfer/Assignment of Claim)
  - c. Creditor's Withdrawal of Claim
  - d. Request for Notice by Creditor
  - e. Reaffirmation Agreement
  - f. Application for Payment of Unclaimed Funds
5. Without the express permission of the Court, I understand that I may NOT file by electronic means any document which requires a filing fee
6. I understand that I may NOT file electronically any document that requires the filer to be admitted to practice before the United States District Court for the Eastern District of Texas.
7. I understand that I must already have a valid PACER account.
8. I understand that, as a minimum in my ECF Account, I must:
  - a. maintain a valid primary e-mail address
  - b. elect to receive Notices of Electronic Filing, individually or in summary, via e-mail in cases in which I am involved

I request that the U.S. Bankruptcy Court, Eastern District of Texas, issue me a login and password so that I can use the Court's Electronic Case Filing System (CM/ECF). My signature on this registration form indicates that I have read and understand the requirements stated herein.
