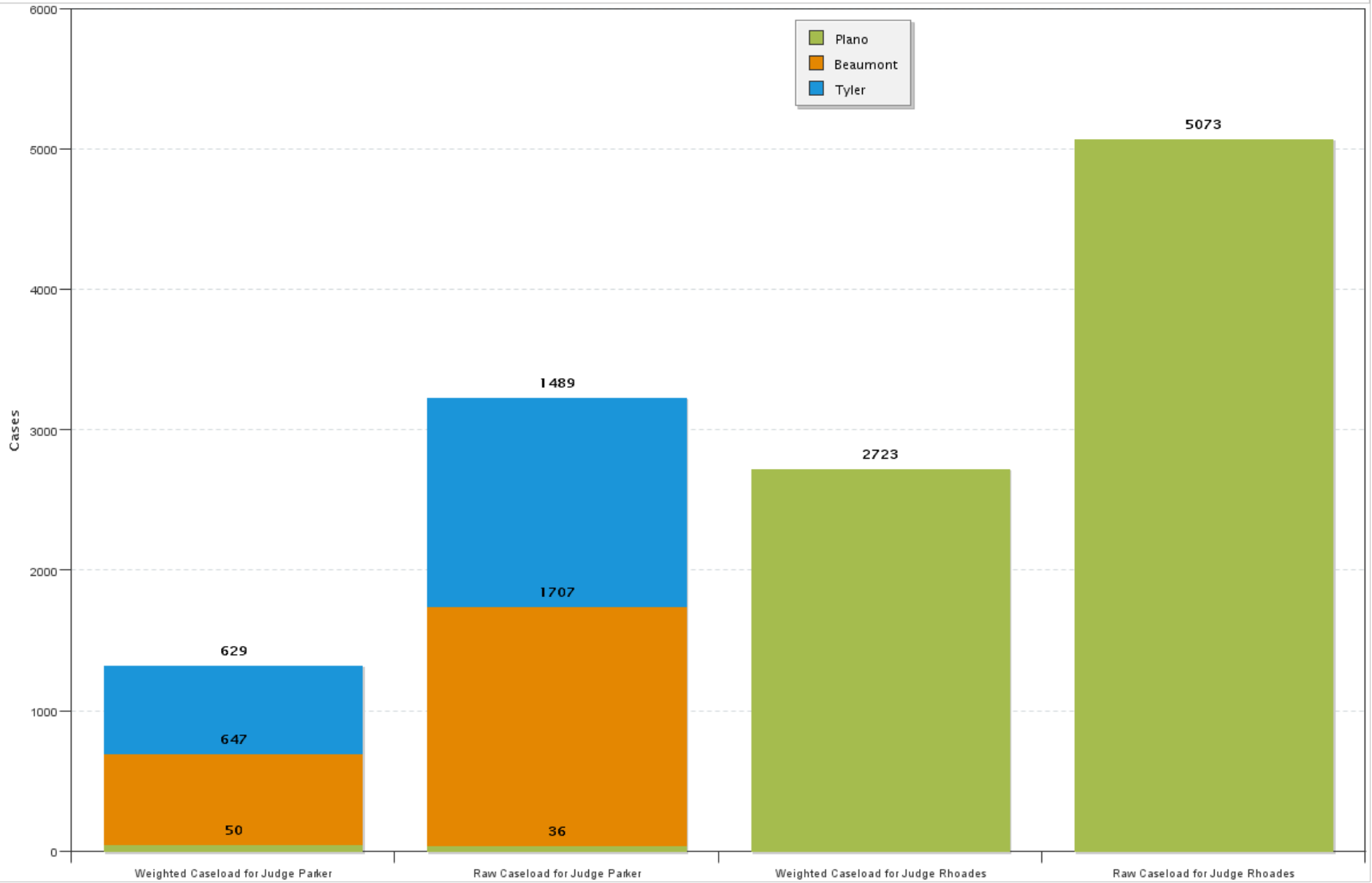

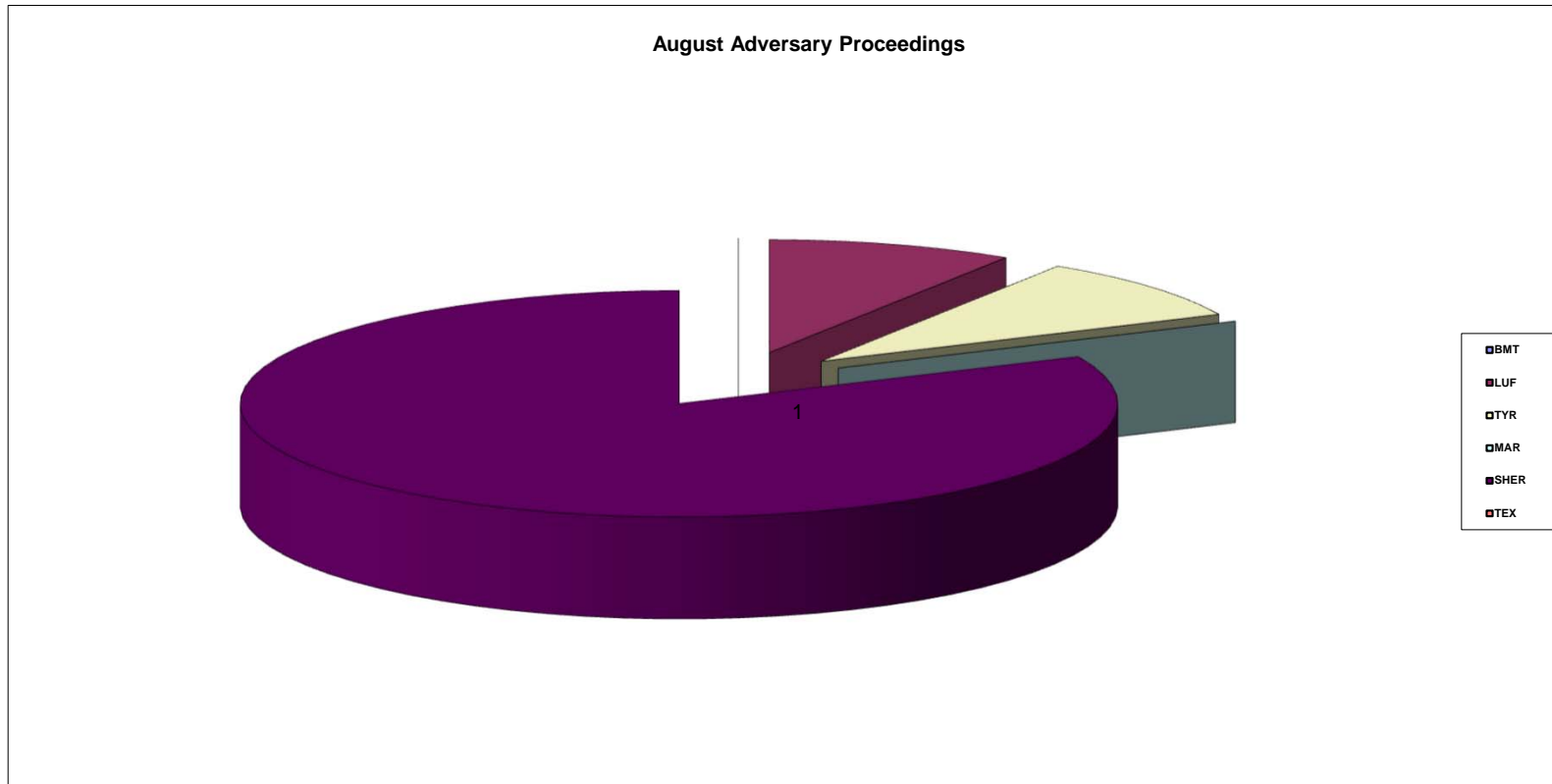

### TXEB Pending Caseload as of 2020-09-01

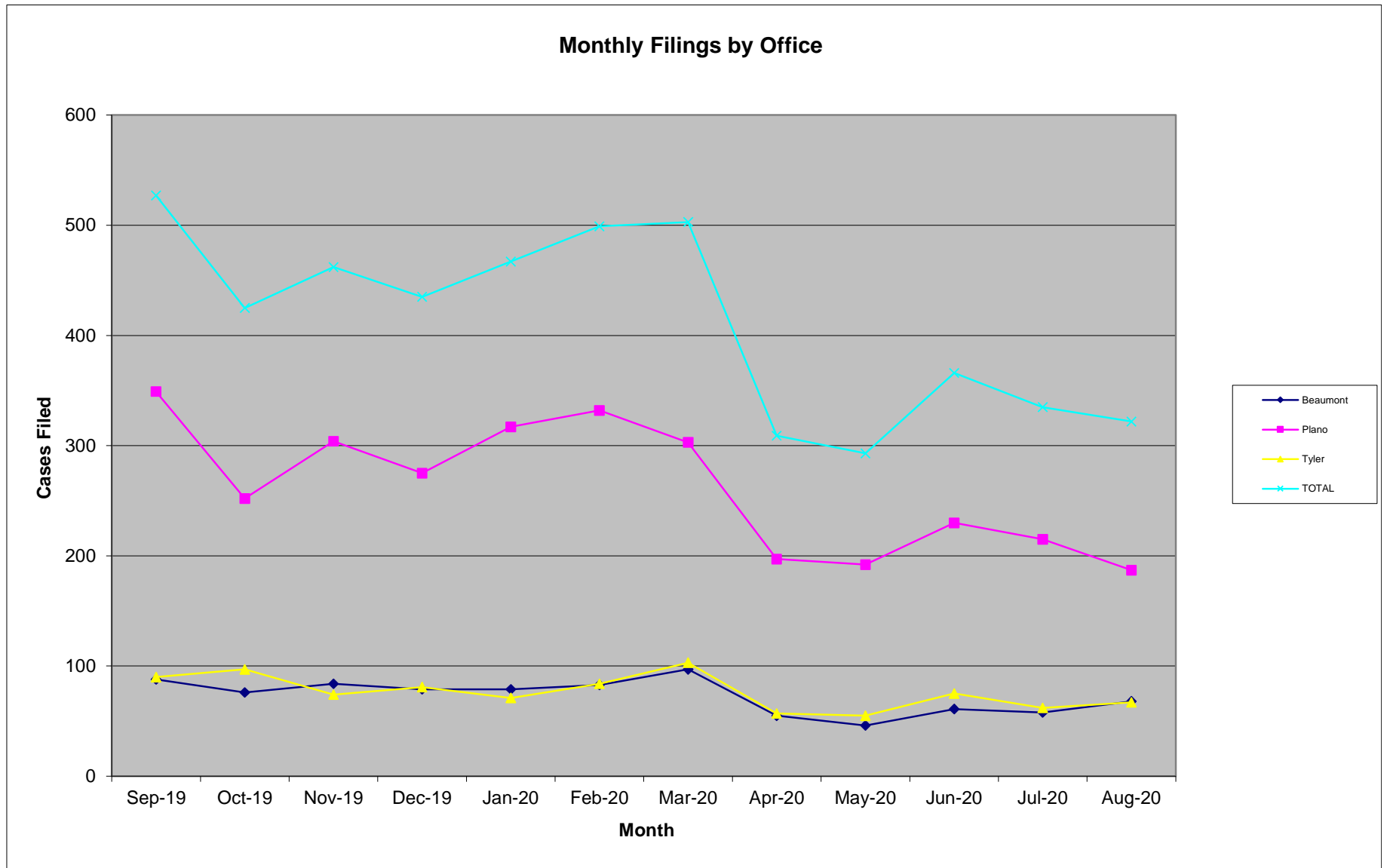
