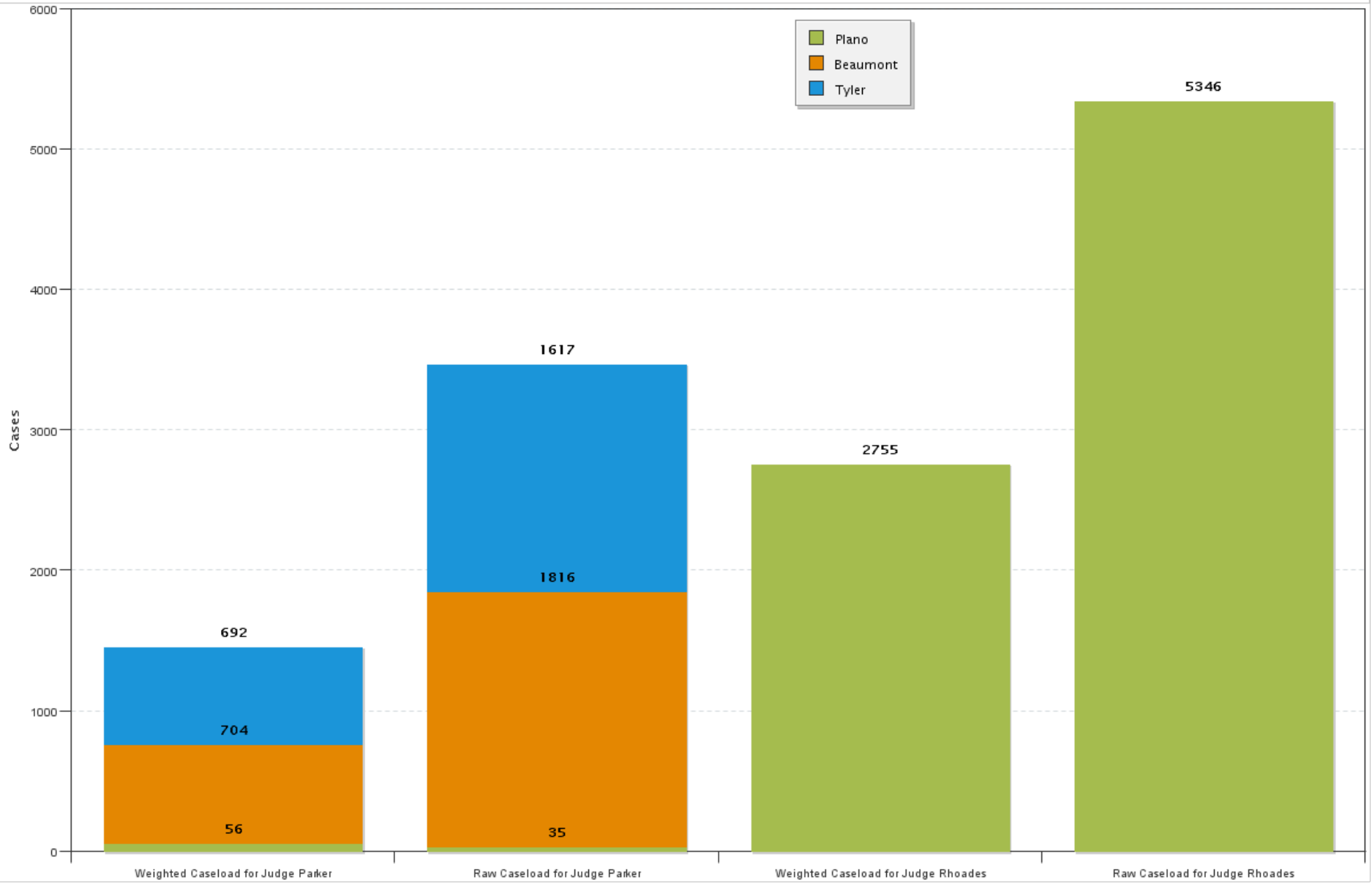

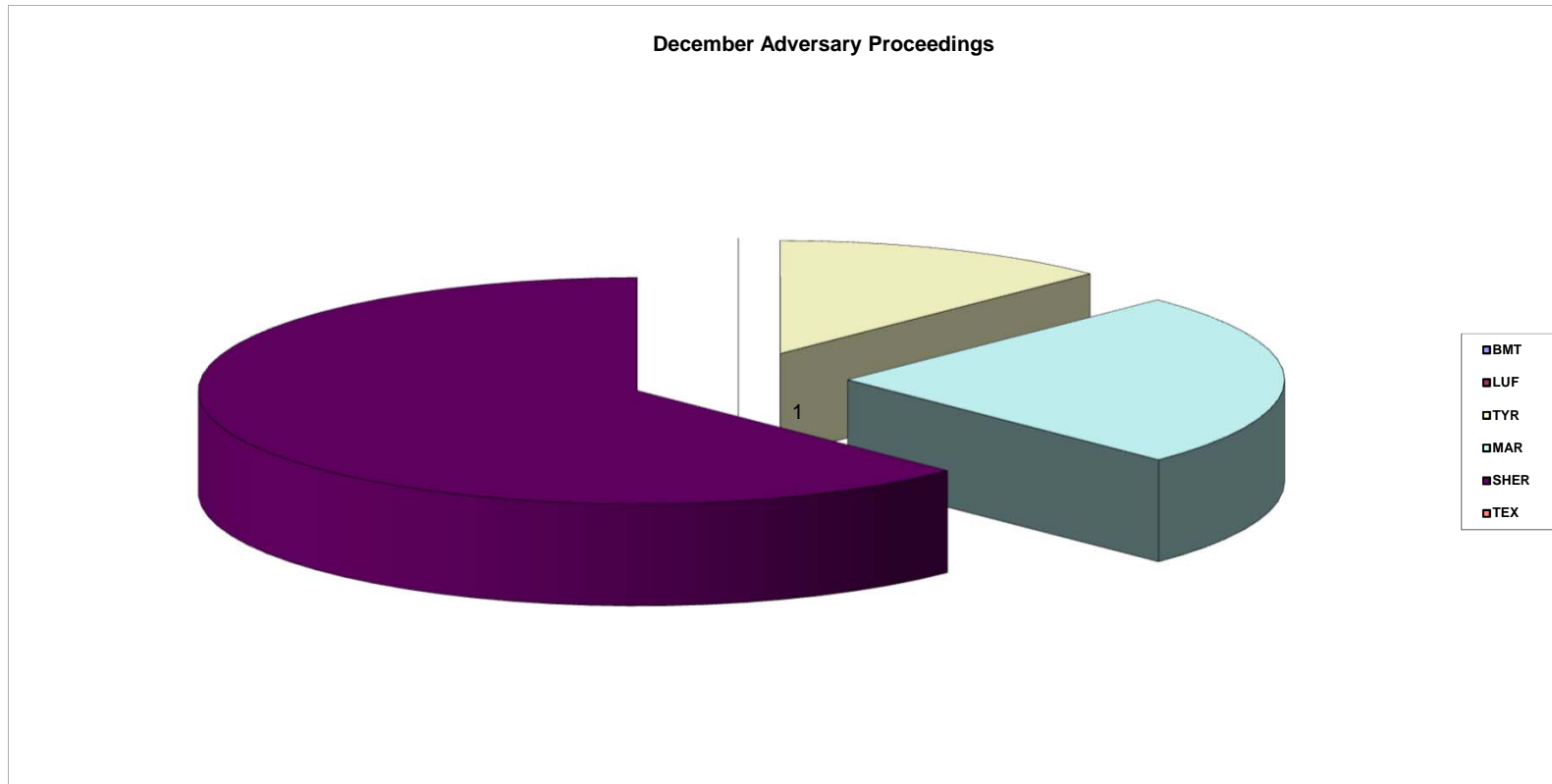

### TXEB Pending Caseload as of 2020-01-01

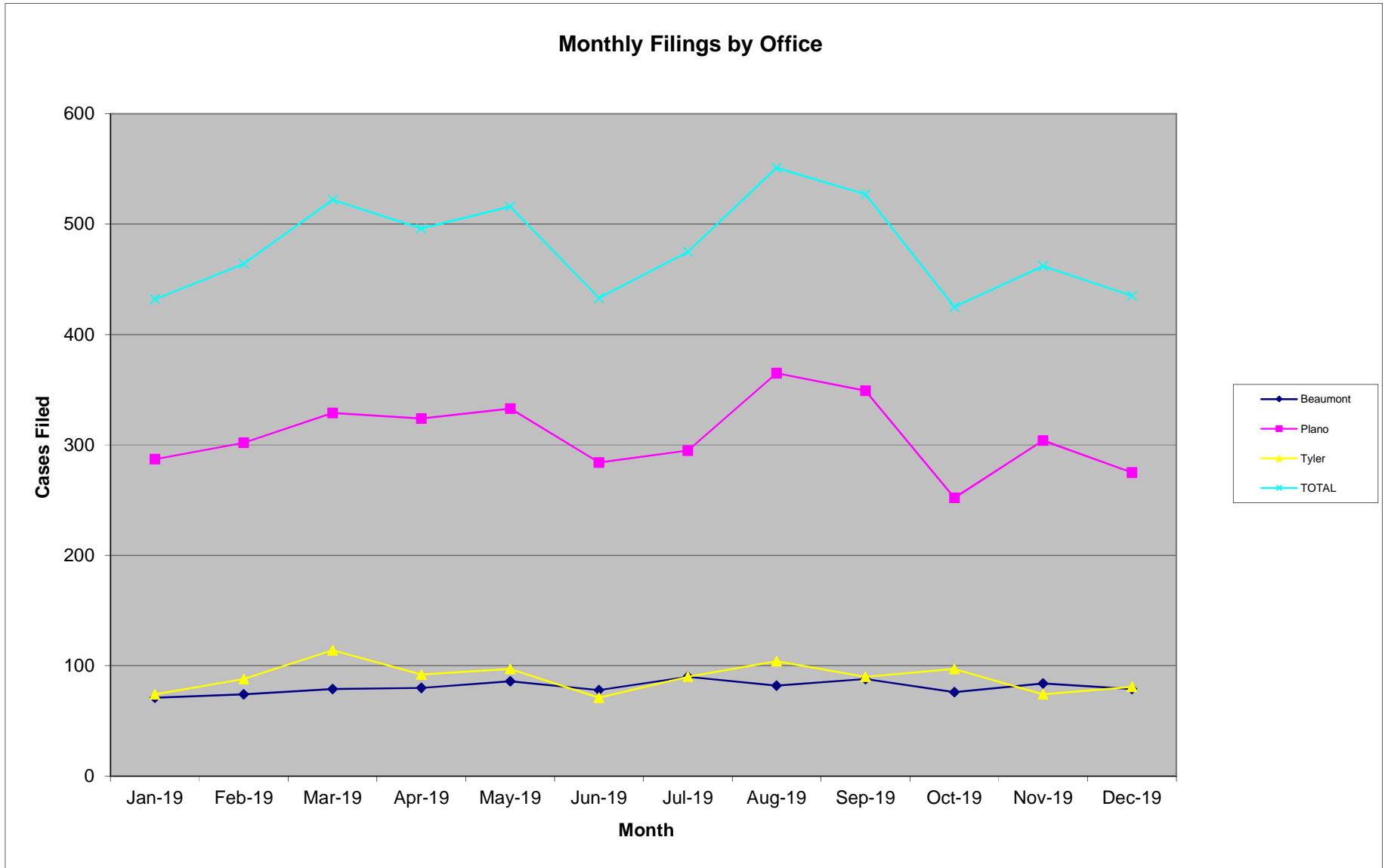
