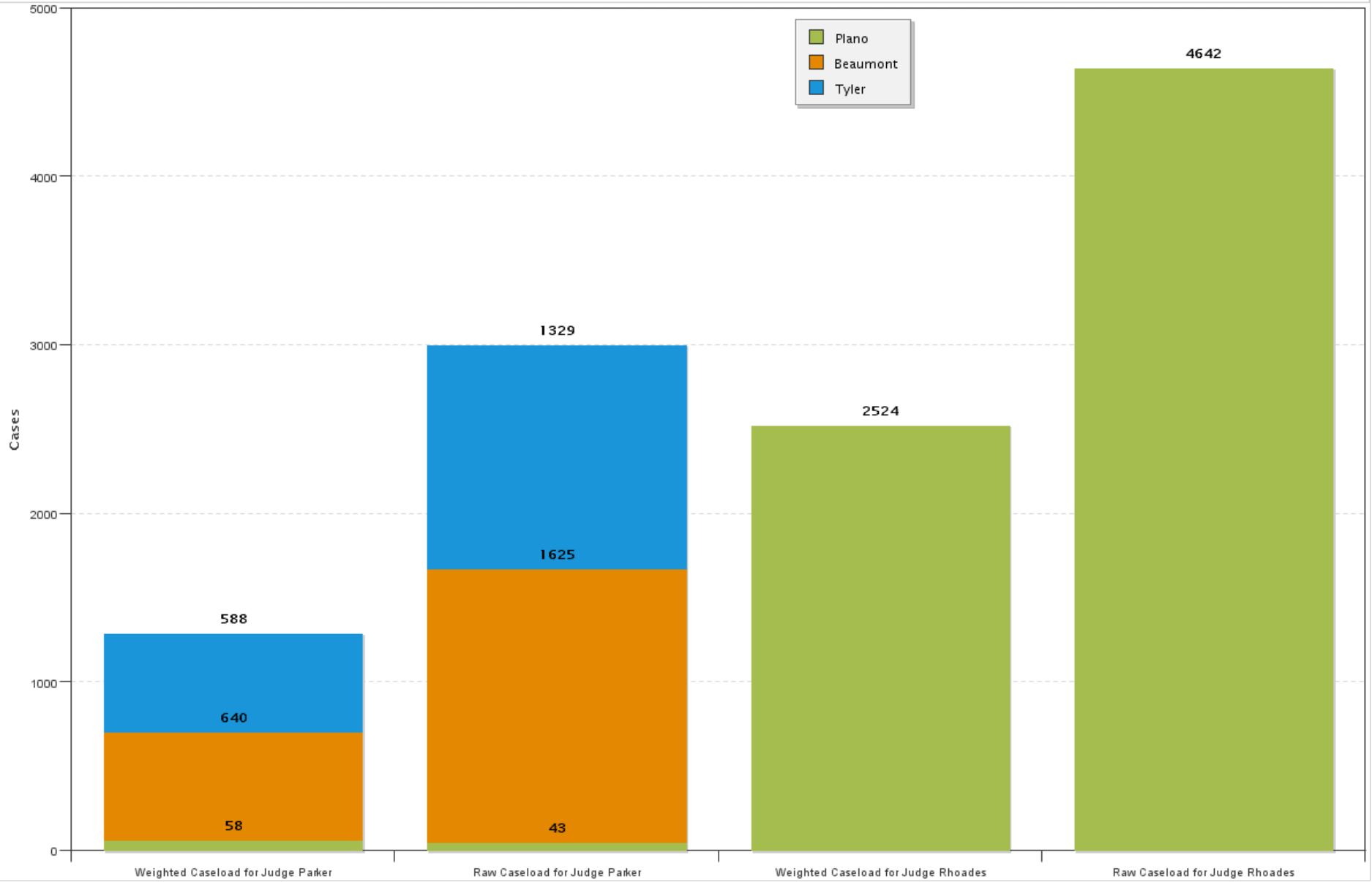

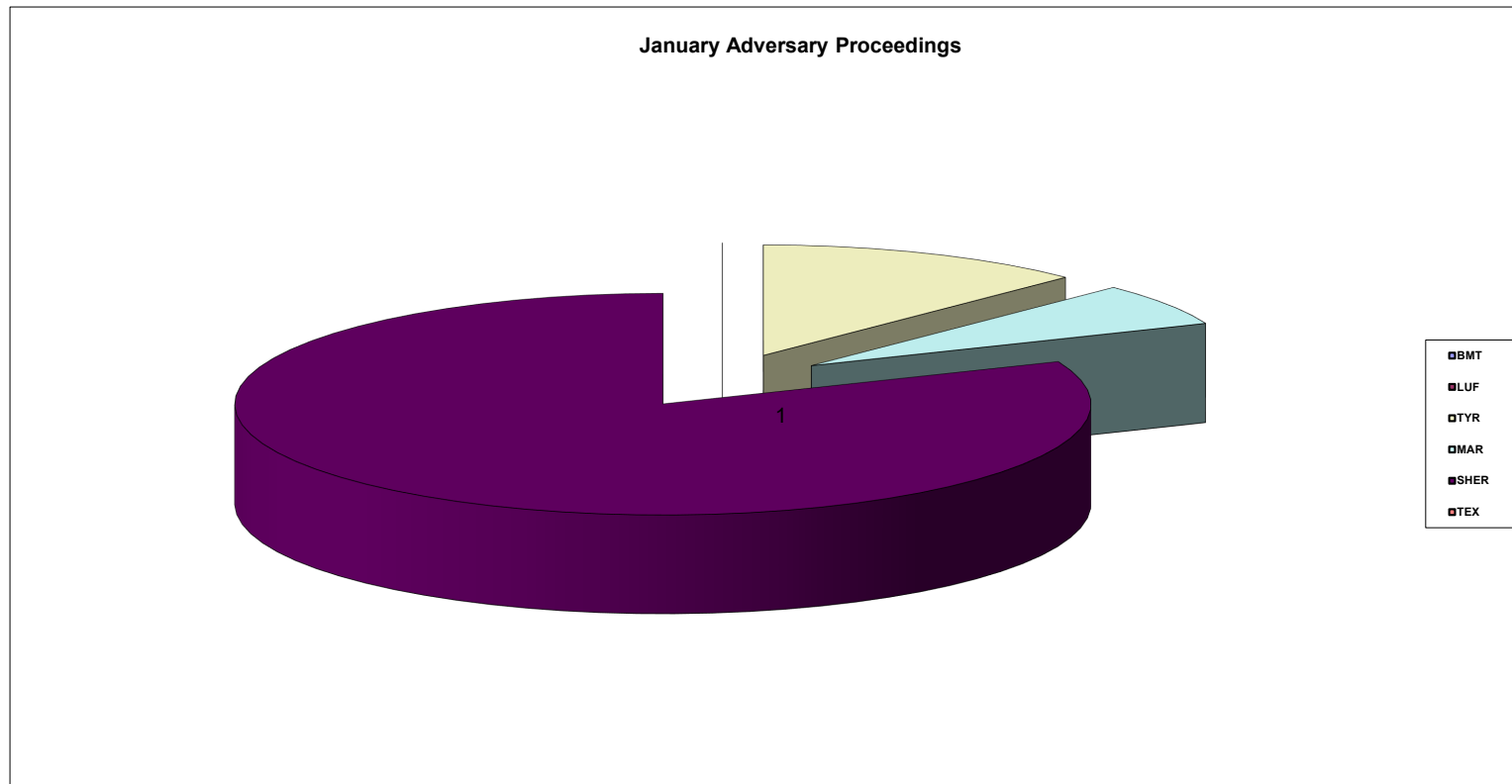

### TXEB Pending Caseload as of 2021-02-01

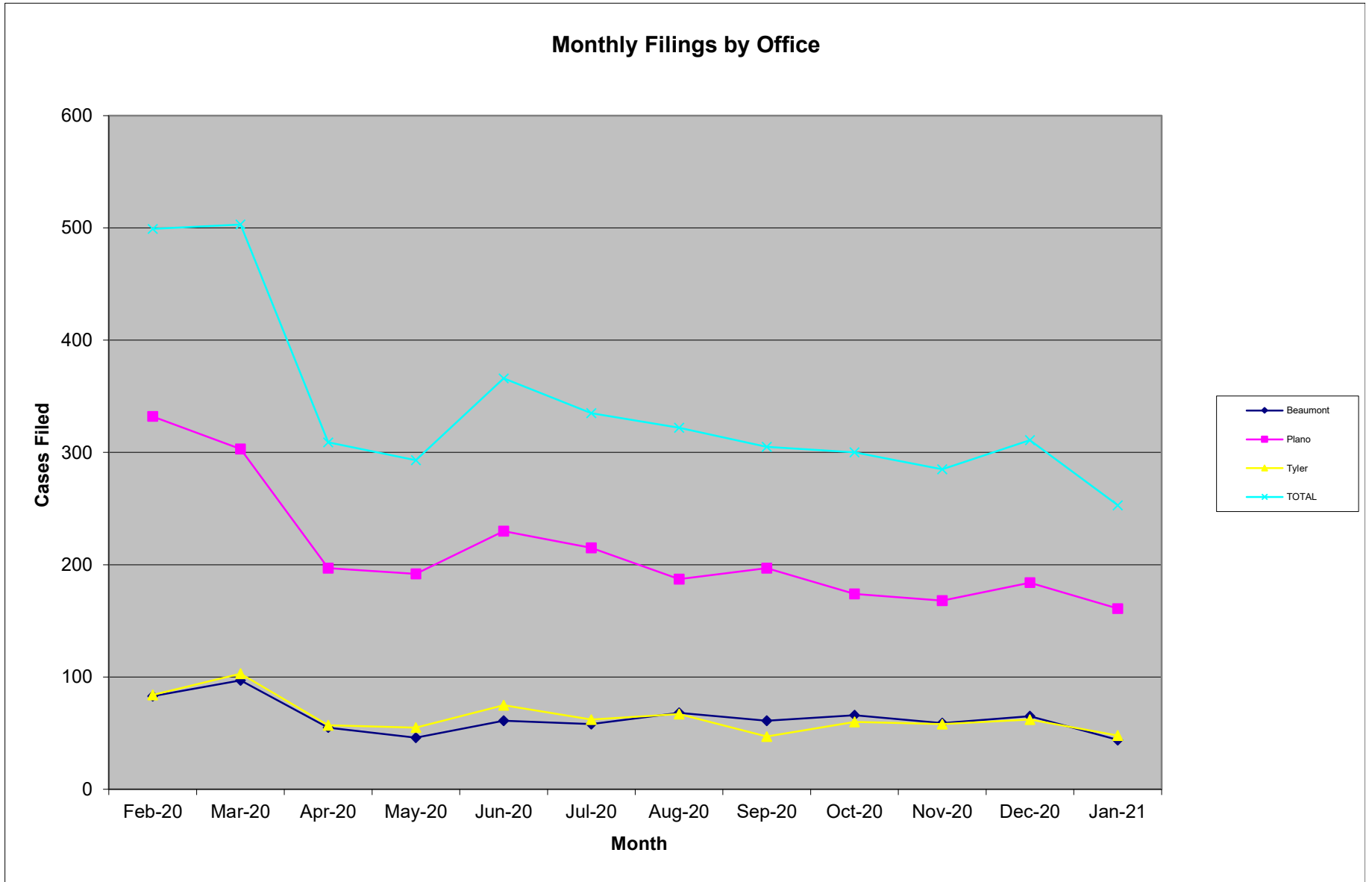
