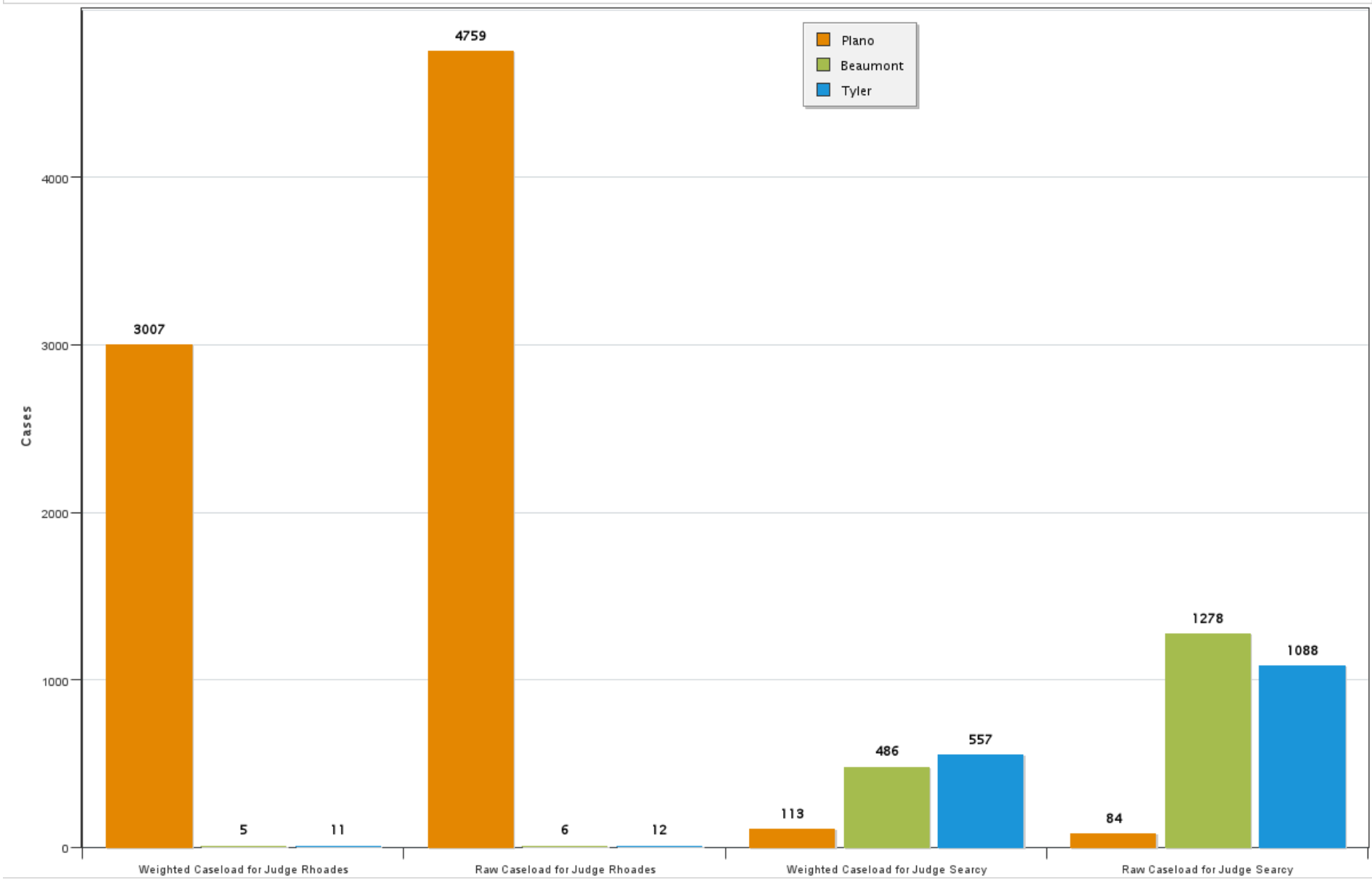

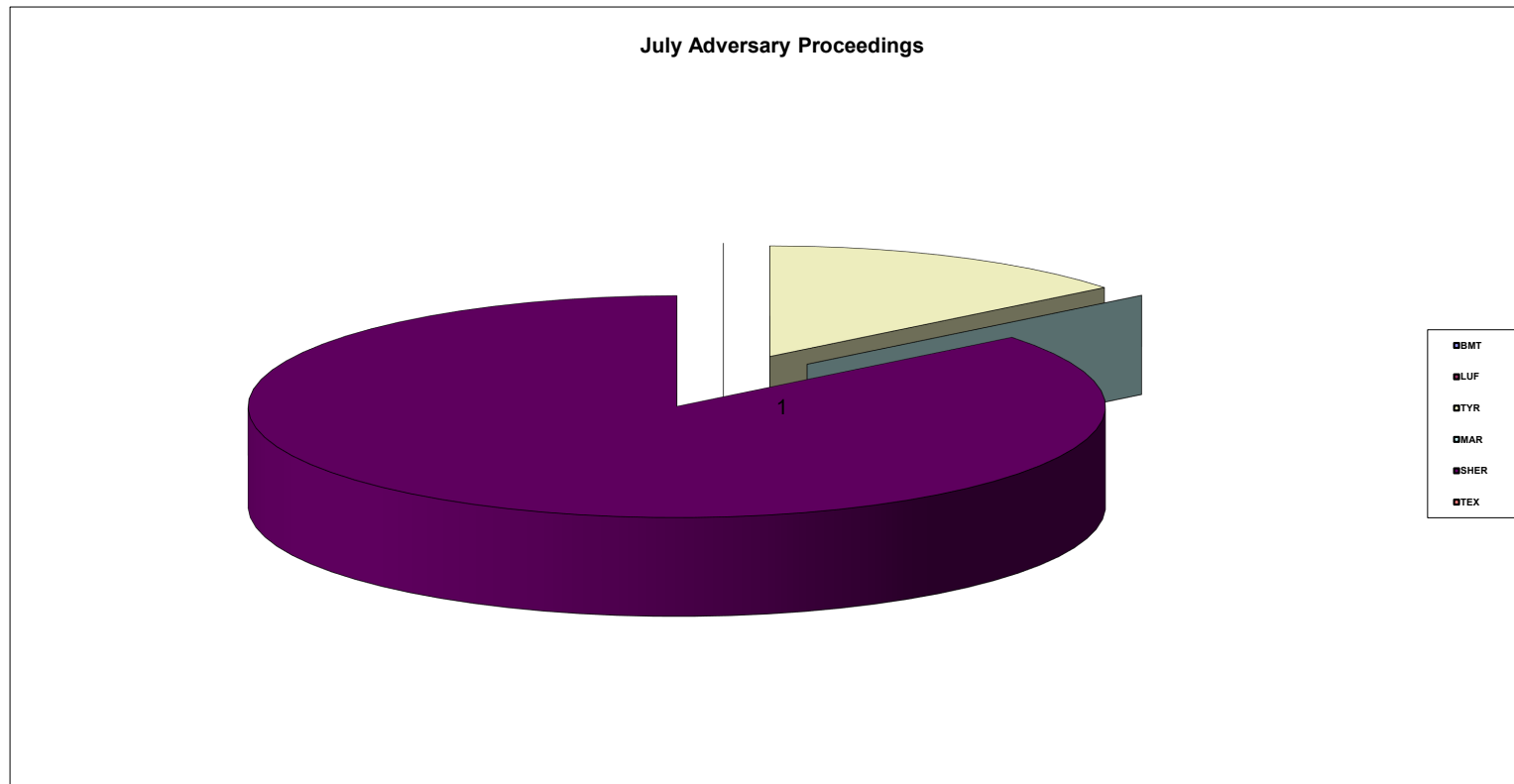

TXEB Pending Caseload as of 2025-08-01

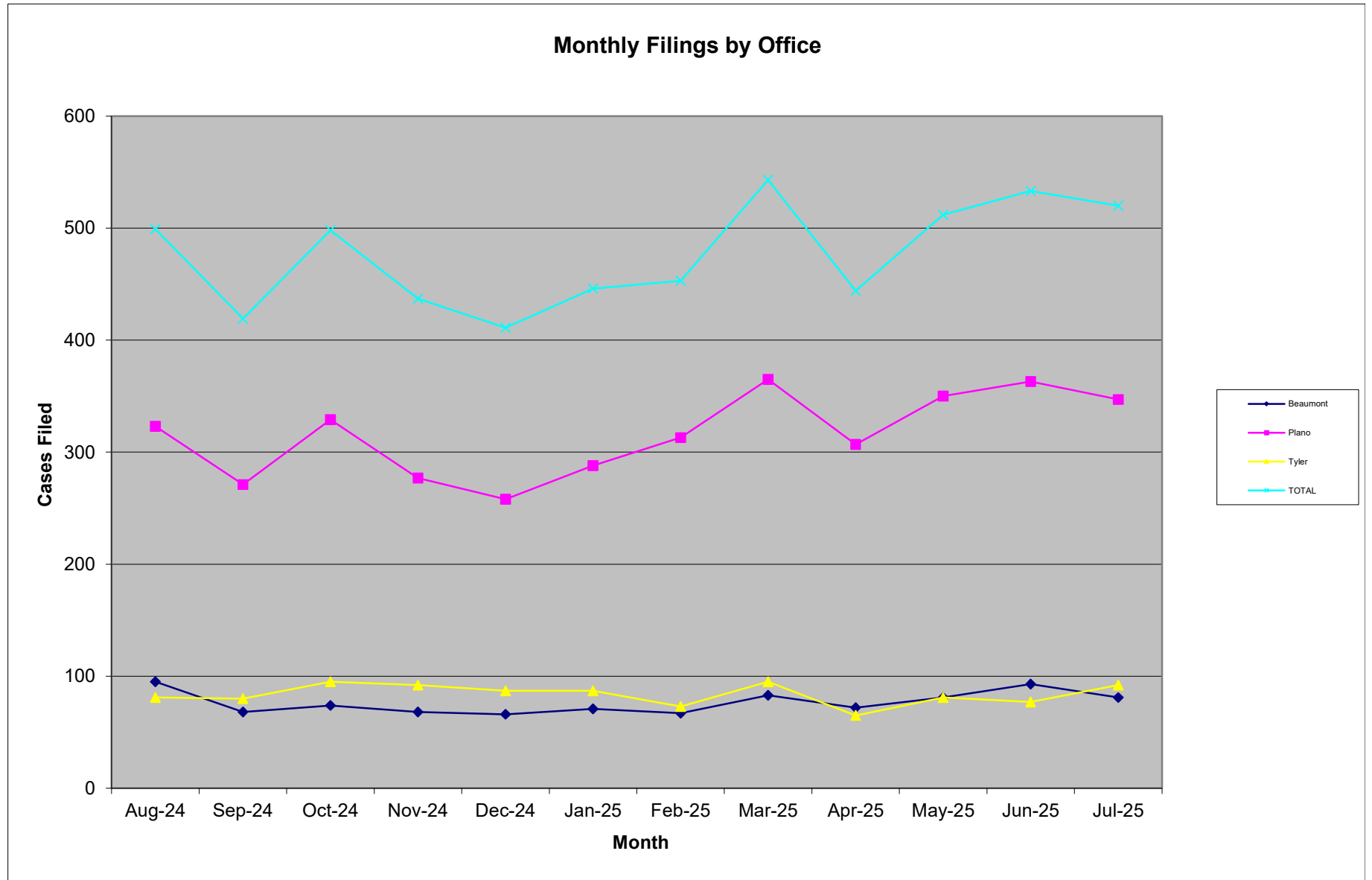
