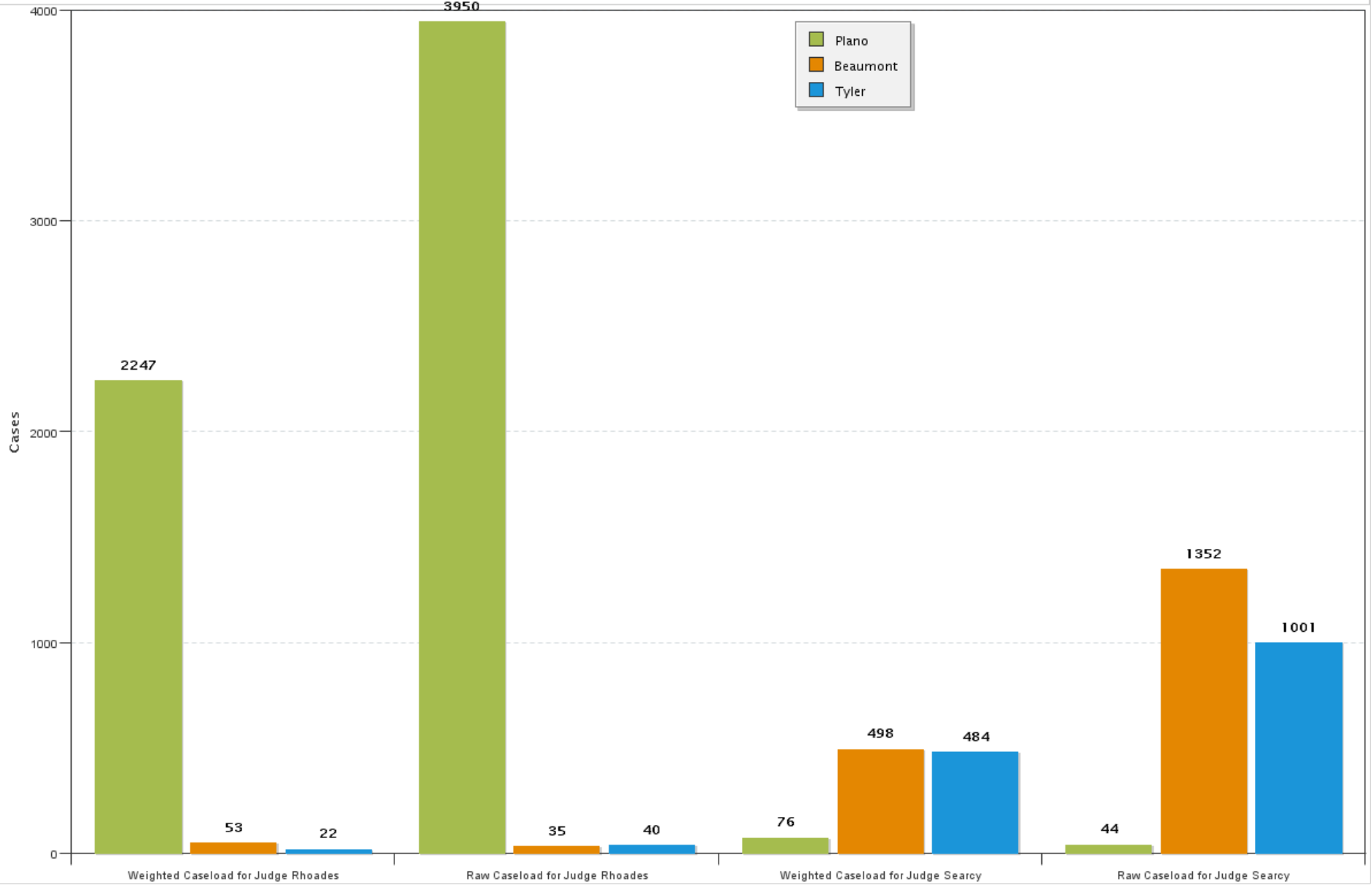

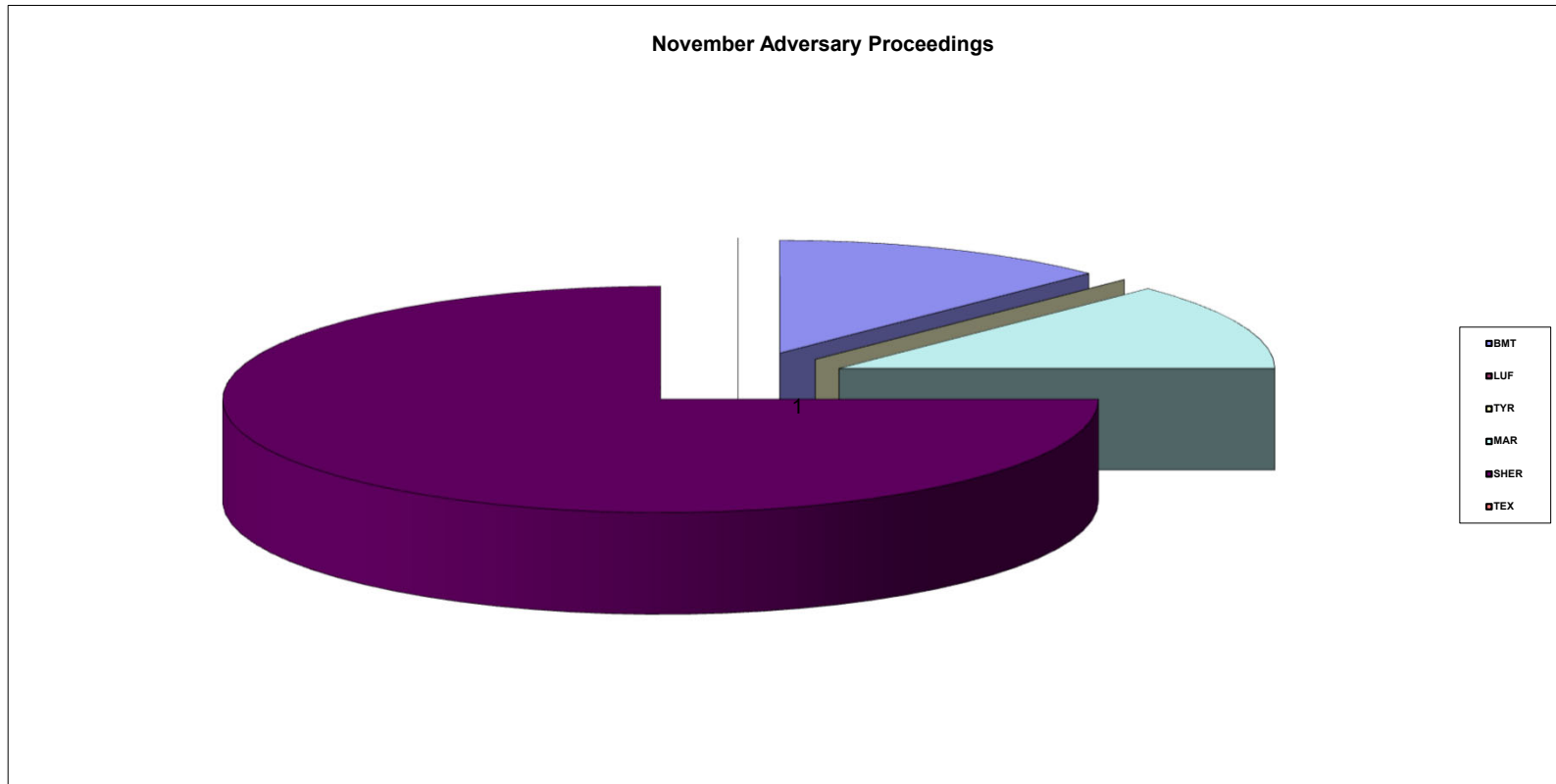

TXEB Pending Caseload as of 2022-12-01

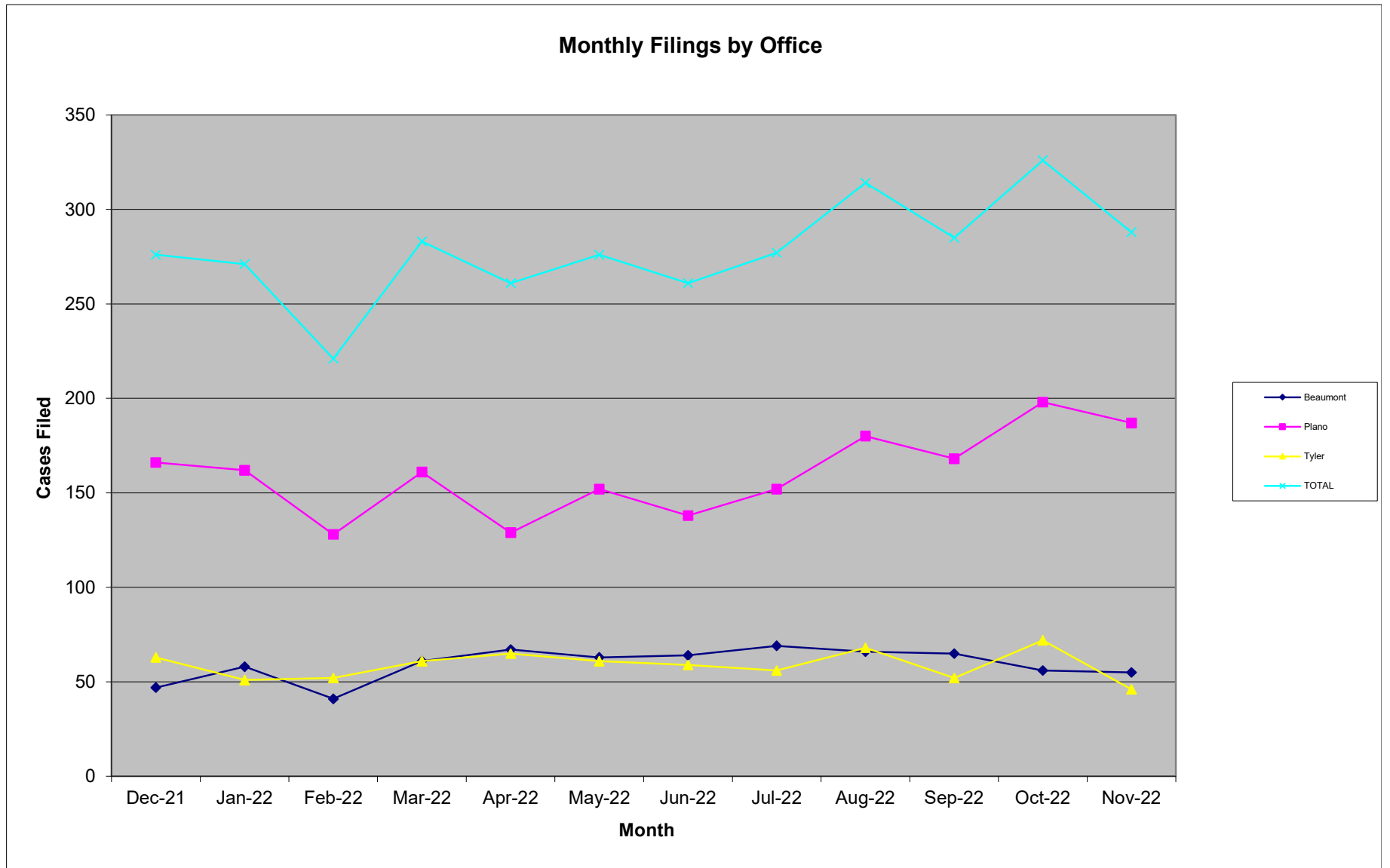
