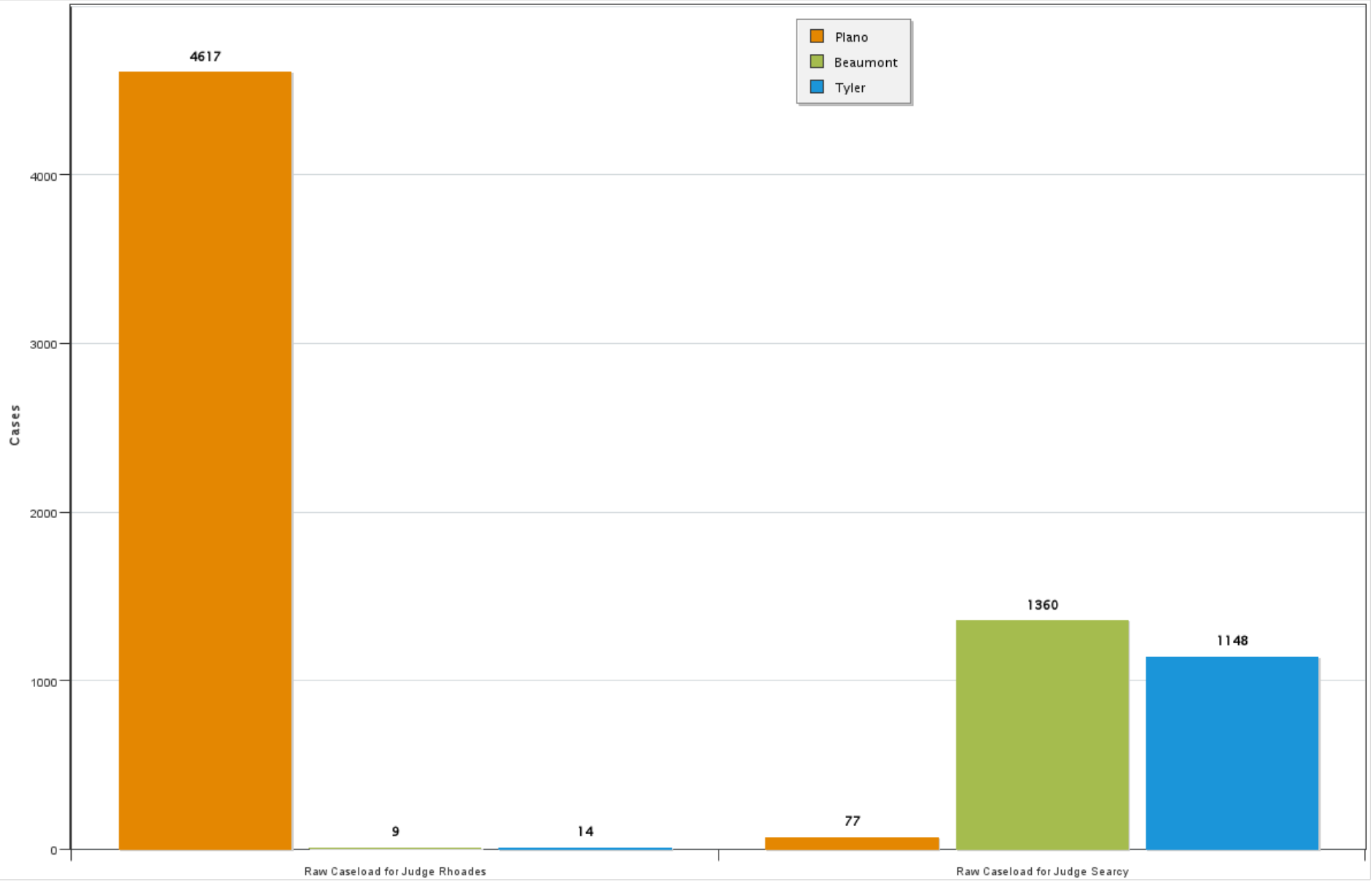

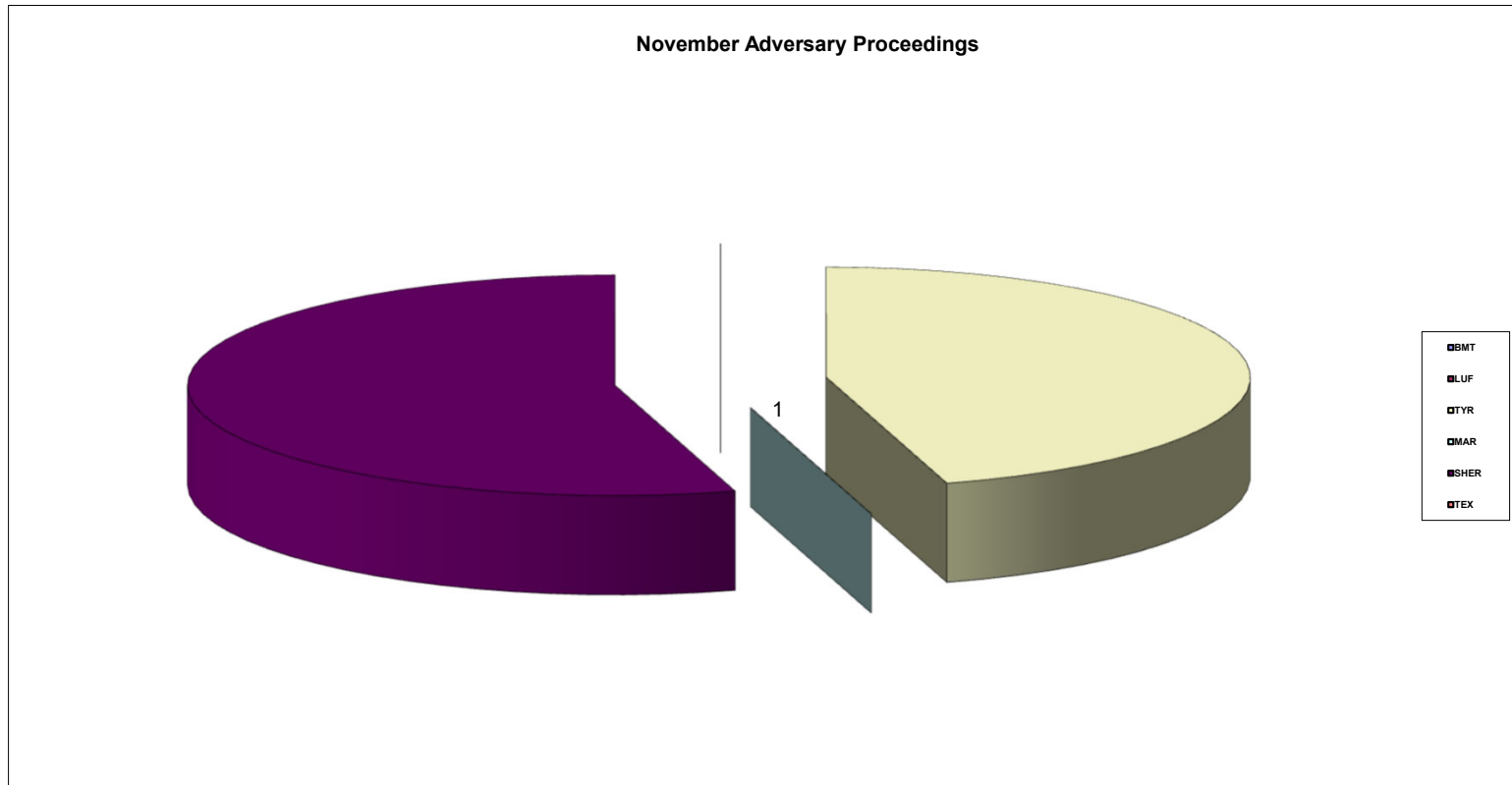

### TXEB Pending Caseload as of 2024-12-01

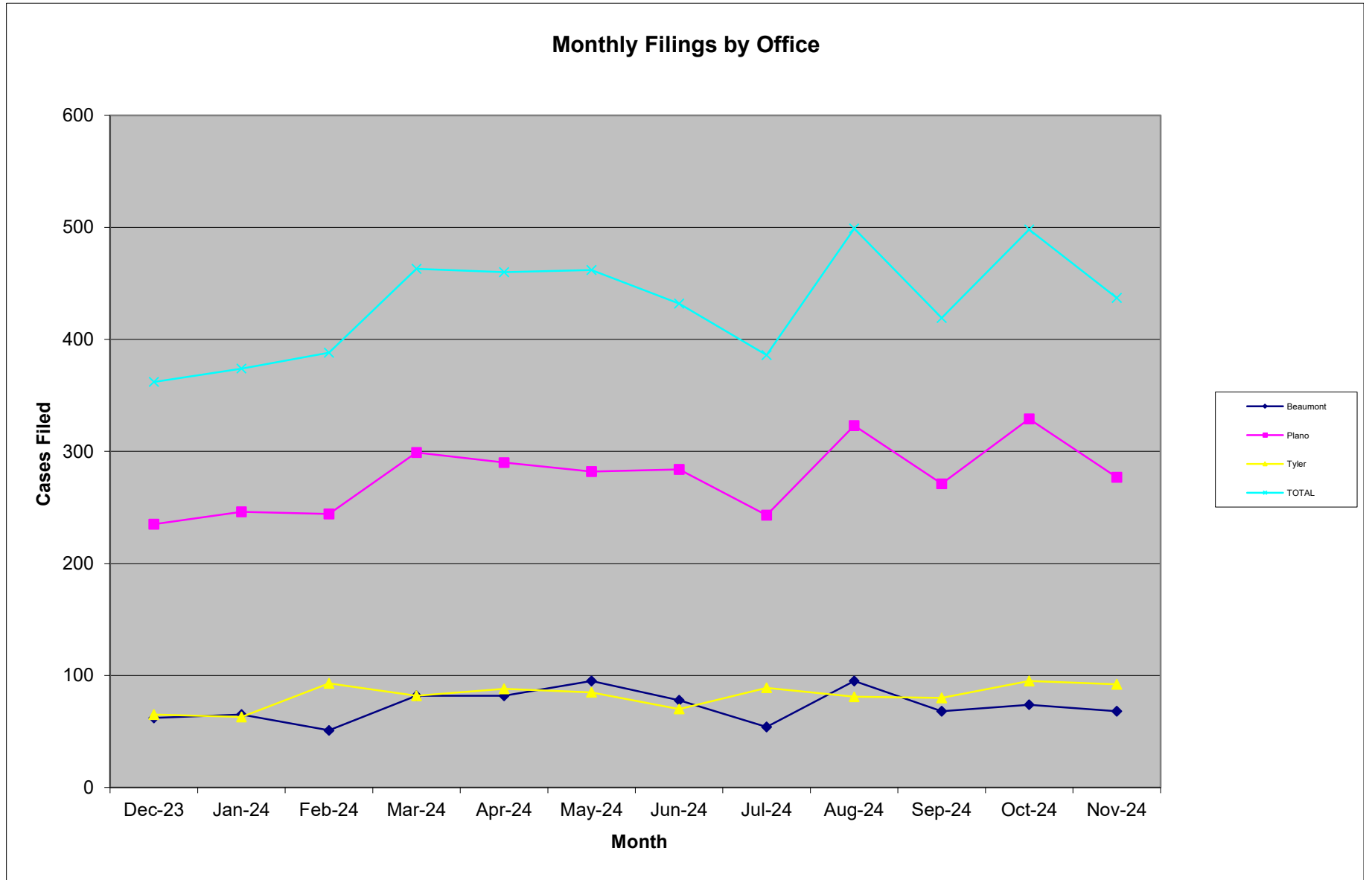
