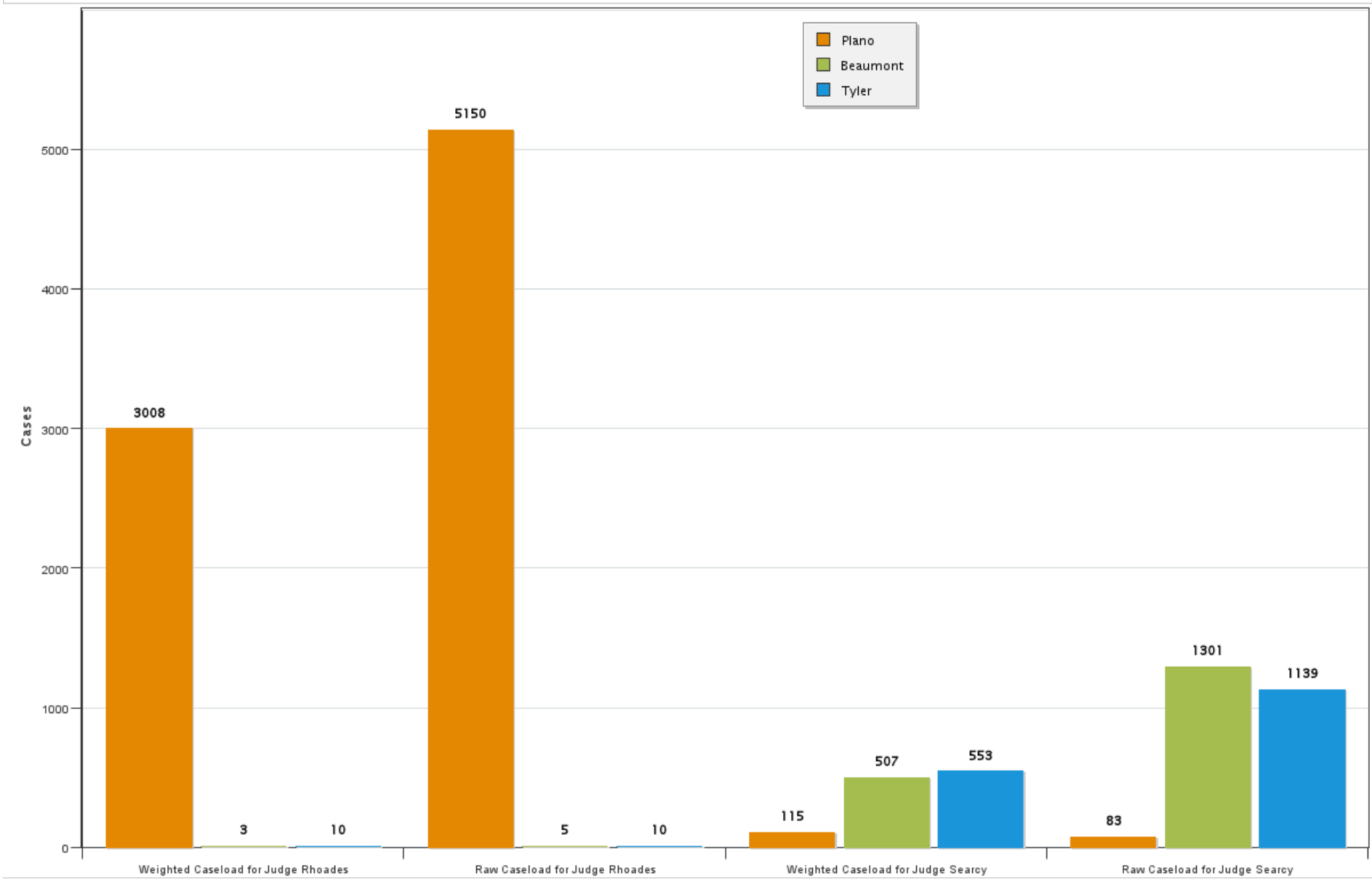

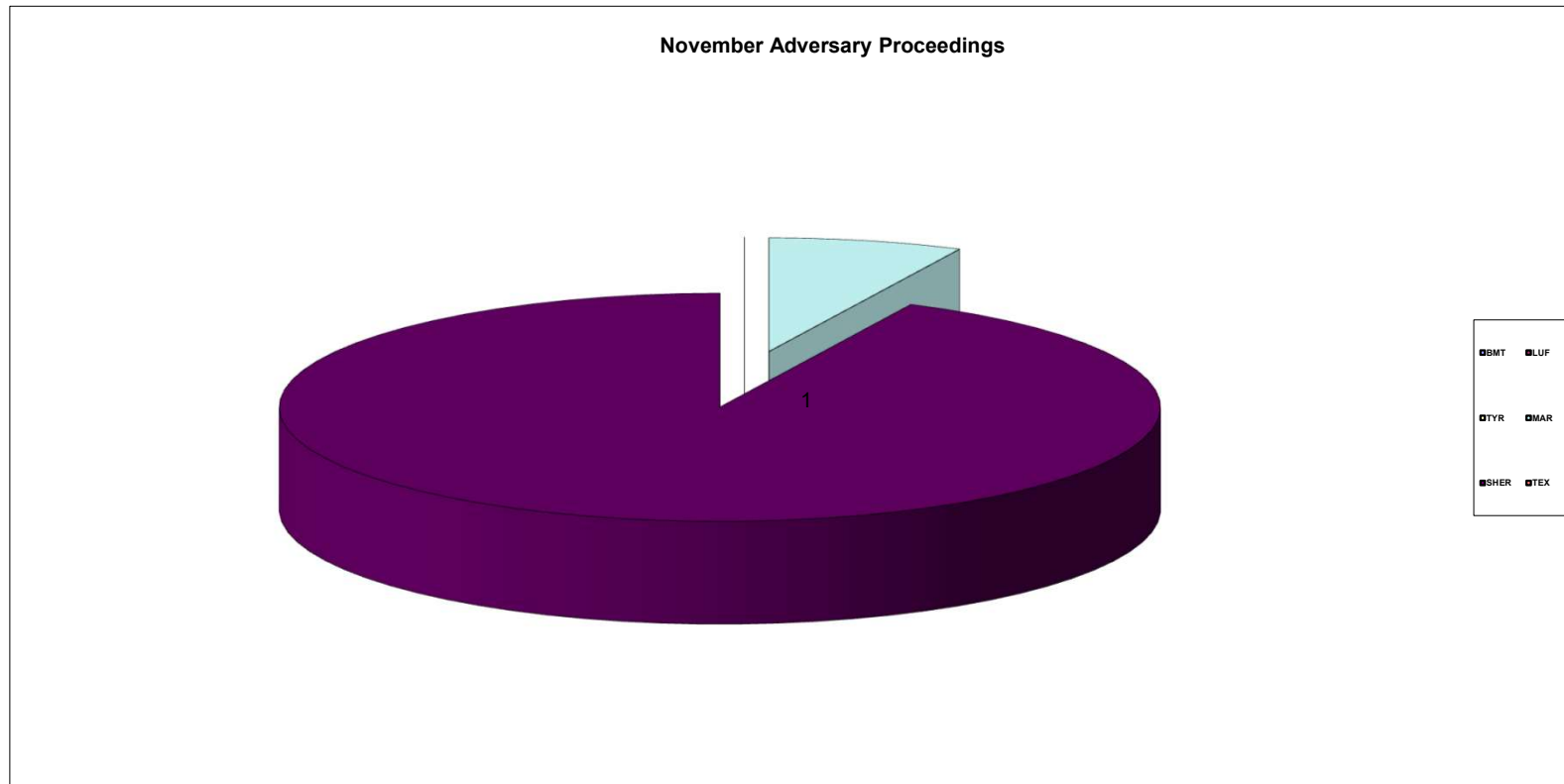

TXEB Pending Caseload as of 2025-12-01

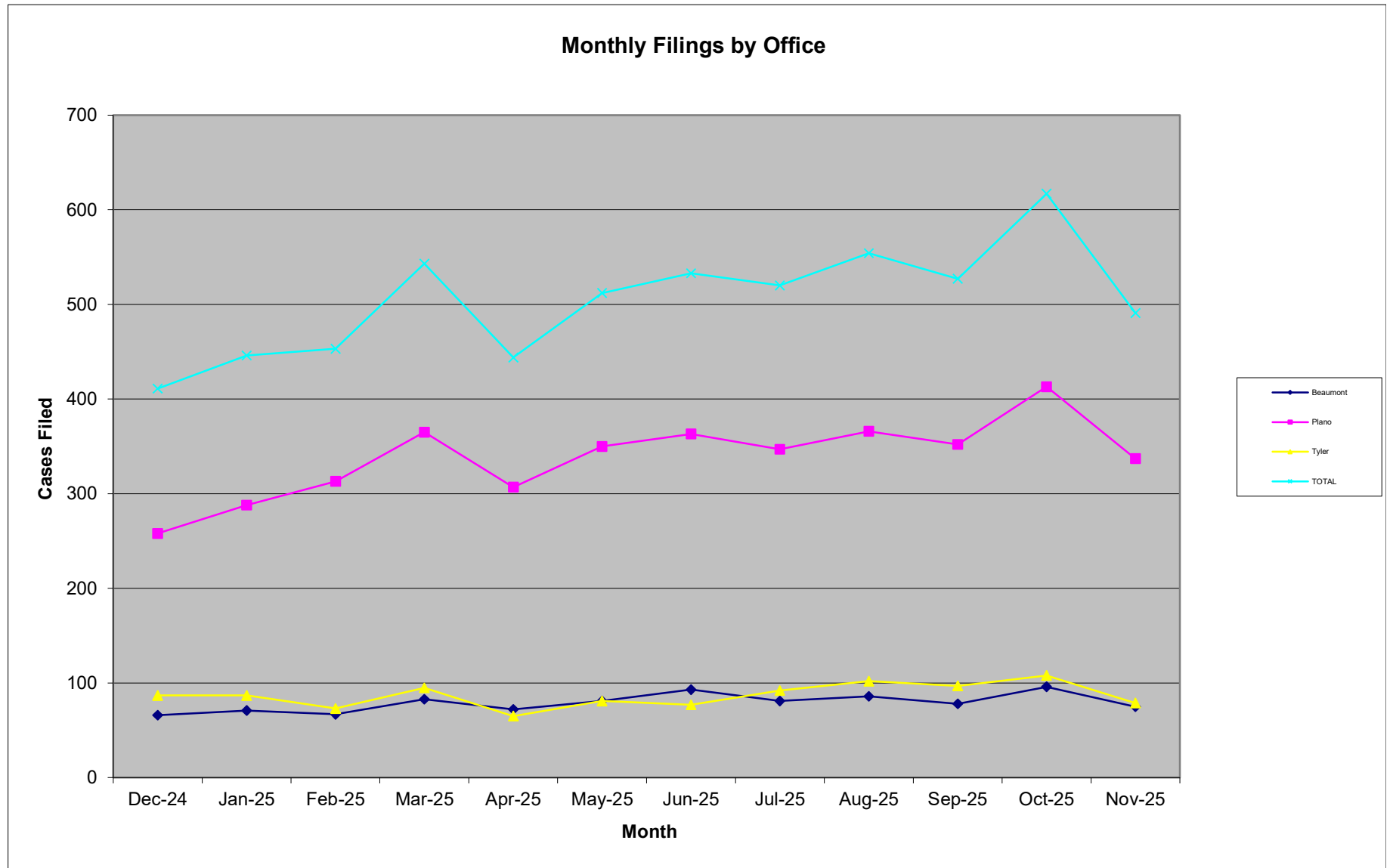
