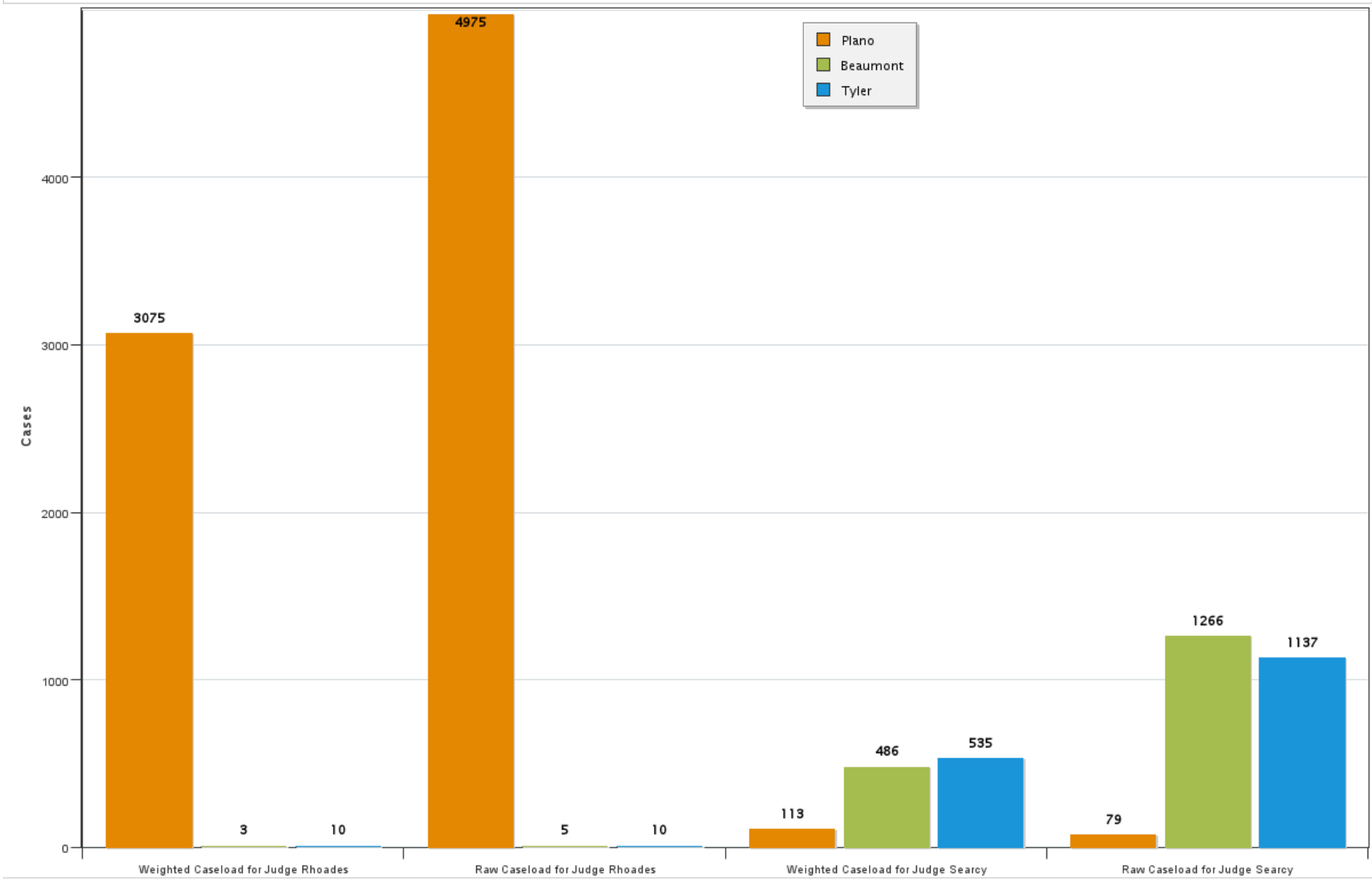

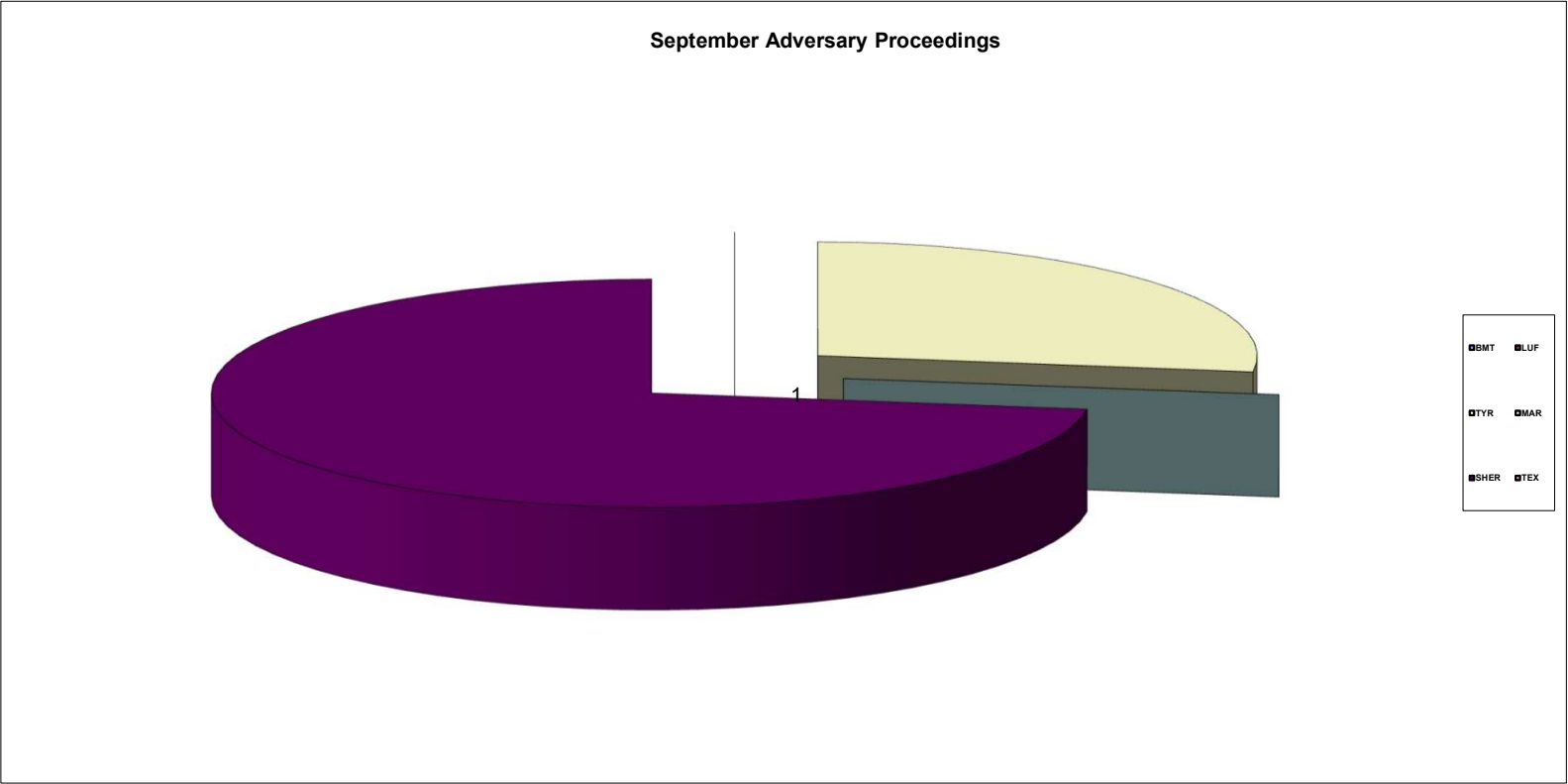

TXEB Pending Caseload as of 2025-10-01

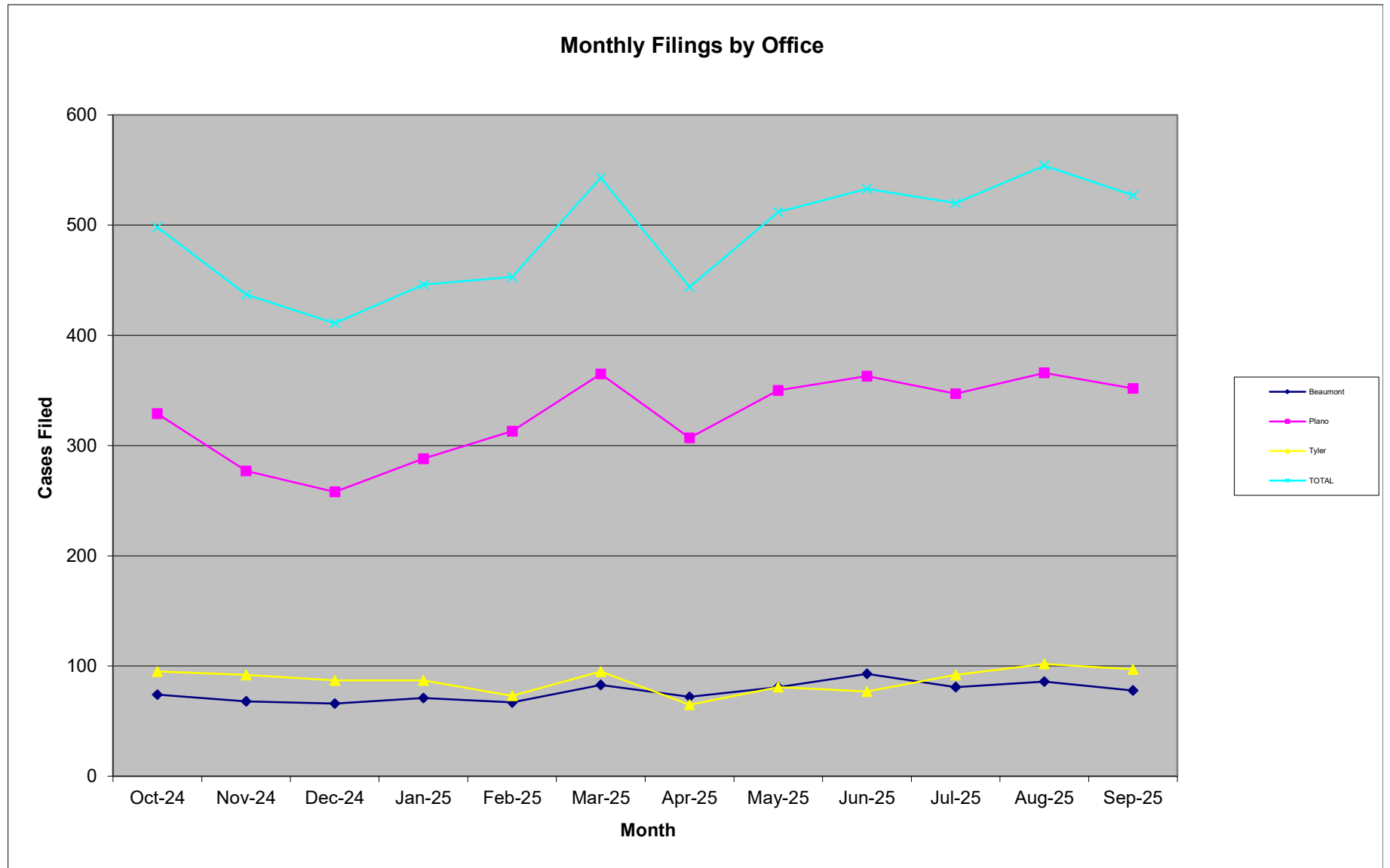
